Synopsis

FYS Marketing Sdn Bhd is the operator of Foo Yen Soo & Sons Sdn Bhd quarry which started operations in 1960s. The quarrying operation involves extraction of granite rock reserves, drilling, blasting, hauling, crushing, screening and sales of granite aggregates to local market.

FYS quarrying best practices ESP model focusing on three levels: **Level-1 Environmental, Safety, Productivity, Level-2 Educational, Social (CSR), People, Level-3 Extra-ordinary, Standardization, and Professionalism.** This model aims to improve the quarry industry image, enhance safety, public education, and professional development and promote responsible quarrying practices while fostering community engagement and tourism. The best practices to minimize environmental degradation and improve the liveability of the community which makes the quarry and community can co-exists are utmost importance.

FYS has become **exemplary model** for the quarry industry in the region with **13 awards and recognitions** received both national and international. Many organizations both national and international have visited the quarry to learn ESP Best Practices. This best practice has presented at forum and conferences both national and international.

Throughout the technical visit, the participants will gain knowledge on how the quarry operation process and observe their working environment. Also, participants can also able to understand the future challenge and opportunity in this industry
